## **First Council Meeting**

Friday, October 2<sup>nd</sup> 2020 Held at PMC, Islamabad

Meeting was chaired by the President and called to order.

The meeting started with recitation of the Holy Quran.

The President welcomed all members of the Council to the 1<sup>st</sup> meeting of the Medical & Dental Council of the Pakistan Medical Commission.

Agenda Item No.1	Brief on PMC Act 2020 and its salient features and functions and responsibilities of the Council.
Discussion	Mr Ali Raza explained the functioning of PMC.  (a) Council (policy making body)  (b) Academic Board  - Curriculum for undergraduates  - Criteria for accreditation of college  - Structure of examination  - Council will have the final approval authority  (c) Authority shall consist of seven members with defined role and authority to run the operational functioning of the Commission.  (d) PMC is principally a licensing regulator for the medical profession and for such purpose will set the standards of medical education and medical institutions to be enforced by the relevant educational regulators working closely with the Commission.  (e) Structure of PMC seeks to cater not only to the current and future needs of regulating the medical profession but also provides for key aspects which are required to be enforced by 2023 to ensure international acceptance and recognition of professionals holding licenses issued in Pakistan.  (f) As part of its regulatory responsibility to ensure quality of education PMC would be recognizing not only under graduate but also post graduate programs as post graduate qualifications are to be entered on the license of a practitioner.  (g) To cater to issues of students graduating from foreign institutions and seeking to obtain licenses in Pakistan the law provides transparency where PMC will evaluate and recognize foreign colleges and foreign programs rather than evaluating individuals.  (h) MDCAT and NLE are the principle new examinations to be conducted by PMC at a national level ensuring a singular standard for all students entering medical colleges and for all graduates seeking to obtain a license to practice

No.2	Appointment under Sec.51(2) PMC Act 2020 of interim Secretary to the Council on a 60 day contract till the appointment of a permanent Secretary as required under Sec.14 PMC Act 2020.
	It was agreed that it was essential to have a Secretary of the Commission appointed albeit on a temporary basis immediately as the Secretary was required not only to ensure the Council's operations but also act as the signatory for licensing etc. There was a discussion on interim appointment of a secretary for 60 days. Dr Shaista Zeeshan was suggested for this position having past experience in the organization. It was agreed that the post will be advertised and interviews conducted for permanent hiring during these 60 days. The interim secretary would be eligible to apply for permanent post as well.
Decision	Dr. Shaista Zeeshan is approved for appointment as Secretary on a 60 day contract basis at a fixed remuneration of Rs.200,000 per month.
Agenda Item No.3	Appointment under Sec.51(2) PMC Act 2020 of interim Director IT on a 60 day contract till the appointment of a permanent Member IT as required under Sec.15(1)(d) PMC Act 2020.
Discussion	IT is a critical department requiring immediate strengthening to ensure the Commission can initiate work on a digital conversion plan. Currently the IT resources available are limited to three people with limited capacity and withou proper leadership. The requirement for an interim appointment of IT Director was discussed. Mr. Raza Shah was suggested for the post for 60 days while the permanent hiring is initiated. Mr. Raza Shah has been a member IT Govt of Pakistan and has experience with the Commission's working.
Decision	Appointment under Sec.51(2) PMC Act 2020 of interim Director IT on a 60 day contract till the appointment of a permanent Member IT as required under Sec.15(1)(d) PMC Act 2020.
Agenda Item No.4	Appointment under Sec.51(2) PMC Act 2020 of Director Communications on a 6 day contract.
Discussion	The requirement of a Director Communication was discussed. Communications an essential requirement of the Commission from the outset as it requires not only communicating the Commissions decisions but also being able to respond to the queries and opinions and suggestions of stake holders. It was however discussed that at this stage rather than hiring a Director Communications as well as a Communications Agency would be premature as first the exact requirement and terms of reference of a Director Communications should be developed base on experience over the next month or so while having an agency with all availabed in house resources manage communications.
Decision	Appointment of a Director Communications was deferred.

No.5	non-digital communications on behalf of the Commission. Public advertisement for submission of proposals to be initiated for final appointment within 60 days
Discussion	As already discussed the immediate requirement of having available a communications expert or agency is essential to cater to all kinds of media as well as social media dissemination of Commissions decisions and operations and responding to queries of stakeholders and public. The profile and proposal of M/s CheckBox Media was considered and found appropriate for the interim stage. The Secretary Ministry of National Health pointed out that the agency was also assisting the Ministry of National Health for in some matters of communications and had performed well. It was discussed that the appointment should be for 90 days being the time permissible under Sec.51(2) of the PMC Act 2020 to allow an assessment of the agencies work and to determine the person who would be required on a permanent basis for in house management of communications.
Decision	M/s CheckBox Media be appointed as the Communications Agency for a period of 90 days on a contract at a fixed fee of Rs.500,000 per month for Communication Services and shall manage all public media communications for the Commission.
	Within 60 days a tender be also floated for appointment of a long term media communications agency.
Agenda Item No.6	Termination of contract of employment of previous Registrar Brig. Hafeez Siddiqui appointed under a temporary contract and to a post no longer in existence.
Discussion	The previous Registrar PM&DC was under a temporary contract granted by the Ad Hoc Council as an interim measure. Upon the passing of the PMC Act 2020 the position of Registrar no longer exists. Consequently, the temporary contract of the previous Registrar also is rendered as incapable of being continued. It was proposed that the President speak to the ex Registrar and if he wishes to tender his resignation the same may be accepted otherwise the contract would stand terminated with immediate effect.
Decision	If Brig. Hafeez Siddiqui as ex Registrar PM&DC tenders his resignation the same maybe accepted with immediate effect otherwise the contract shall stand terminated with immediate effect as the post is no longer in existence. Finance Department to prepare his final accounts and clear his dues.

Agenda Item No.7	Formation of Human Resource & Administration Committee of the Council under Sec.8(2)(q) PMC Act 2020. HR Committee to be mandated to develop organogram within 30 days.
Discussion	There was a discussion with regards to HR Committee. HR Committee would be an essential requirement as all old departments have ceased to exist as have all previous designations. With the new seven mandated departments existing employees need to be assessed in terms of their capacity and abilities to assign them to the new departments. Furthermore, appointment of the new seven members of the Authority has to be initiated immediately. The Council members were requested to indicate their availability to serve on the HR Committee.
Decision	The Human Resource Committee of the Council pursuant to Sec.8(2)(q) of the PMC Act 2020 is formed with the following as its members

Agenda Item No.8	Initiation of process for appointment of Members under Sec.15 PMC Act 2020. Process to be completed within 45 days. President to approve interviewing committees for each position on the recommendation of the HR Committee.
Discussion	The process of appointment of members as provided under the PMC Act 2020 was elaborated and it was explained as to how it would be initiated. The HR Committee was mandated to approve the necessary criteria for each position of member provided under Sec.15 PMC Act 2020 and publish an advertisement for inviting applicants for shortlisting and interviews.
Decision	The process for appointment of members pursuant to Sec.15 PMC Act 2020 be initiated immediately by the HR Committee after finalizing the criteria for each post. The HR Committee shall interview the shortlisted candidates on the criteria basis and the top three candidates for each position would be finally interviewed by the Council. Any existing employee of PMC would be at liberty to apply for the post of member.
	The terms and conditions for the post of members to be finalized by the HR Committee and Finance Committee jointly and shall be approved by the Council.

Discussion	In view of the existing designations becoming non-existent and no right existing to previous posts the members discussed the immediate need to assign work to employees. It was noted that under PMC Act 2020 there exist seven departments as provided in Sec.15 of the Act and employees should be reassigned work under these departments or divisions of these departments as may be advisable in the interim until a detailed organogram is developed for this
Decision	No existing employee shall carry any immediate designation and shall be assigned work based on immediate priorities under any of the seven departments. The HR Committee may create any interim divisions under a department where found necessary to ensure efficiency of work.

Discussion	It was discussed that in view of the urgent need to initiate work and focus on immediate priorities which included licensing, verifications, certifications, MDCAT and admissions it would be the most efficient to authorize the President and Vice President who would be available at PMC on a consistent basis to assign work to employees on need basis. A detailed analysis of the existing human resource in terms of capacity and capabilities was required to determine a long term

Decision	The President and Vice President shall at the interim stage assign work to existing employees of PMC until further decision of the Council. The HR Committee shall develop the organogram for each department for consideration of the Council. The HR Committee shall further assess and evaluate the existing human resource in terms of capability and capacities and submit a report within 45 days to the Council with their recommendations.
Agenda Item No.11	Formation of Finance Committee of the Council under Sec.8(2)(q) PMC Act 2020.
Discussion	Formation of Finance Committee of the Council was an immediate and urgent need to oversee the financial operations of the Commission. Members were requested to offer their time for this important task.
Decision	The Finance Committee of the Council pursuant to Sec.8(2)(q) of the PMC Act 2020 is formed with the following as its members Mr Tariq Ahmed Khan (Chair) Dr. Asif Loya Mr. Aamir Ashraff Khawaja, Secretary Health The Committee may co-opt any person to the Committee as required.
	The Finance to oversee all matters relating to Finance and make recommendations to the Council or the President as the case may for decision and/or implementation.
Agenda Item No.12	Mandate to Finance Committee to develop new fee structure for different applications submitted to the Commission and for registrations etc. and an interim operating budget till June 2021 within 60 days.
Discussion	An immediate need was to assess the fees the Commission would be charging for different services provided from applicants including registrations, licensing etc. It was important to ensure the Commission charges fees which represent the cost of such services and not burden doctors and students with extra charges on account of service fees. This would be directly connected to the budget of the Commission. It was discussed that in the interim till the Finance Committee recommends a new fee structure the existing fees may be continued where applicable.
Decision	The Finance Committee to develop a budget for the Commission from current date till 30 <sup>th</sup> June 2021. The Committee to further assess and recommend to the Council a new fee structure for all services offered or undertaken by the Commission. Until approval of new fee structure the existing fees shall be continued to be charged. The Finance Committee to place both before Council within 60 days.
Agenda Item No.13	Mandate to Finance Committee to develop a salary structure including allowances and benefits for the Commission within 45 days.
Discussion	The Commission is required to develop the salary structure along with allowances and benefits to be provided to its employees. It was essential to do so at the earliest. The structure should be based on ensuring employees are compensated for their work and their capabilities rather than a static pay scale structure with

	automatic increments solely based on period of employment.
Decision	The Finance Committee is mandated to develop a pay structure for all employees to include salaries, allowances and benefits within 45 days and submit to the Council for its approval. The Finance Committee to consult with the HR Committee in developing the structure based on the organogram being develope for each department.
Agenda Item No.14	Authorizing Finance Committee to appoint an interim Director Finance on a 60 day contract till the appointment of a permanent Member Finance as required under Sec.15(1)(e) PMC Act 2020
Discussion	It was also discussed that the Commission currently has an accounts manager who has been with the organization for some years but is on deputation from the AGPR on a temporary basis. With multiple immediate issues including developing of budgets and audits etc. until such time as a permanent Member Finance is appointed, the Commission will require the services of an interim Director Finance to handle the matters and assist the Finance Committee.
Decision	The Finance Committee is authorized to assess and recommend an interim Director Finance for a 60 day period on contract to the President for appointment
Agenda Item No.15	existing employees to continue to receive basic pay and basic allowances permissible, to be quantified by the Finance Committee, for the months of October and November 2020 as an interim measure. Such payments are on a temporary basis and shall not be fixed or permanent right to such remuneration. Salaries for September 2020 shall be paid as accrued under previous structure.
Discussion	As the Commission was yet to develop a permanent salary structure which work had been assigned to the Finance Committee on a priority basis and to be completed within 45 days, it is necessary for the Council to approve the pays of existing employees in this interim period. The Council has the authority under the PMC Act 2020 to determine any salary and terms and conditions of service for employees of the Commission.
	The previous salaries and benefits being paid by PM&DC were reviewed. There existed multiple anomalies and it appeared there was no structure of compensation in terms of a person's capabilities and assigned work rather it was simply on the basis of time based increments and additional increments at the mere executive discretion. A glaring example was represented by the fact that the highest paid employee was a private secretary while officers were receiving less. An additional issue existed in respect of a health allowance equivalent to one basic pay which was initiated back in 2012 by adopting an allowance which had been sanctioned by the Federal Government for some category of employees. The result was that effectively the basic pay of each employee had been doubled. This was severely objected to in consistent audit reports by the Auditor General's office and even directed to be recovered. It was discussed that the nature of such allowance and its legal implications would be determined in the final audit of past accounts which would be undertaken to determine the PM&DC employees dues as had to be determined however, in view of the objection by Auditor General's office which appeared to have merit, it would be incorrect of the Council to continue to authorize any such payments.

Discussion	In view of the change in law the Commission was required to immediately conduct the national MDCAT exam which was a mandatory requirement for admission to any medical or dental college in Pakistan. While next year the Academic Board would be tasked to prepare the exam structure and to be conducted by the Commission, the current year required an alternative solution. It was imperative that all students were treated equally across Pakistan and had level playing field in terms of merit placement by being offered the unified single exam to assess their merit for admission to medical and dental college.  It was discussed that previously each admitting university of each province
	developed their own MDCAT exam based on the F.Sc syllabus of the province or the federal board in the case of federal colleges. The only exception was NUMS who had developed an MDCAT using a common syllabus based on all provincial and federal syllabi and this exercise had been further vetted by the IBCC as NUMS colleges were open to students from all over Pakistan. Hence, the most appropriate option would be appoint NUMS on behalf of the Commission as an examination body for 2020-2021 for the national MDCAT.
Mac	The Surgeon General informed the Council that NUMS can certainly make a unified MDCAT paper and check the same ensuring security of the process. This process should also involve all provincial universities previously mandated to hold respective entrance exams so as to ensure that there the national MDCAT conducted by the Commission did not exceed the syllabi of any province, federal or any other recognized F.Sc board.
	The Surgeon General advised that it would be difficult for NUMS to conduct the exam in terms of the logistics involved for the actual holding of the exam across Pakistan as NUMS was also holding its prescheduled entrance exam for NUMS constituent, affiliated and administered colleges in October 2020 and limited resources at this time.
	It was suggested that an experienced entity with necessary resources be hired for providing the logistic services to the Commission for holding the MDCAT in addition to NUMS who would prepare the paper and mark the same.

In view of the logistics involved and after considering the time required by public universities for the admissions and then the private admissions of colleges, it was agreed that the MDCAT exam be scheduled for the 2<sup>nd</sup> week of November with the final date to be determined by the Council on the recommendation of the Examinations Committee. It was agreed that in view of the urgency in the matter the Vice President, the Surgeon General and the Secretary Health will coordinate to assess what further assistance in logistics can be provided by NUMS and the provincial governments to the Commission and provide such input to the Examinations Committee. Dr. Rumina Hasan pointed out multiple requests she had received from students from Gilgit Baltistan regarding difficulties faced in previous MDCATs where they had to travel to Islamabad and also in terms of timing as their final board exams were being held in October. It was noted that the exam dates will not clash as the MDCAT would be in 2<sup>nd</sup> week November. The issue of difficulty was noted by all members and it was agreed that this year the Commission would ensure centers for MDCAT exam would be setup in Gligit Batlistan for the ease of students resident there. NUMS be appointed on behalf of the Commission to prepare the MDCAT paper Decision and to check and mark the papers in a secure manner. The MDCAT paper shall be prepared to ensure that it did not exceed the syllabi of any province, federal or any other recognized F.Sc board. A committee be formed for preparing the structure and scope of the paper with necessary stakeholders including IBCC. A third party be hired, by the Commission for providing the logistics and services for holding the exam across Pakistan. In view of the urgency and emergency requirements procurement of services may be considered on an expedited basis pursuant to PEPRA rules. In addition any support made available by the provincial governments and the federal government may be utilized. The MDCAT exam to be held in the 2<sup>nd</sup> week of November with the final date to be determined and announced by the Examination Committee after assessing all aspects. The MDCAT would be mandatory for all students seeking admission to any public or private medical or dental college in Pakistan irrespective of any additional entry exam or criteria any public college may require or as may be permitted to any private college by the Council for the 2020-2021 admissions. Notice to be issued to all Provinces to structure provincial central admissions on Agenda Item merit for public colleges with prior information to PMC. No.20 This was a requirement under the PMC Act 2020 as the provincial governments were mandated to undertake the admissions to their respective public colleges Discussion under a policy framed by the provincial governments. Notices to be issued to all Provinces and the Federal Government to announce Decision the criteria and policy for merit based admission to their respective public colleges at the earliest subject to taking into account their qualifying the National MDCAT.

Discussion	The members discussed the draft policy in detail and suggested certain changes in dates and methodology.
	It was agreed that all students without exception shall be required to take MDCAT for admission to medical colleges. The Surgeon General confirmed that ever army cadets admitted the Army Medical College will be mandatorily required to qualify the MDCAT as part of the national law and requirements.
	It was agreed that while under the PMC Act 2020 private colleges can establish their criteria for admissions, this year in view of paucity of time students would not have sufficient time to be aware of such criteria hence selection on such basis by them would be placing them in an unfair position. It was noted that currently only Aga Khan University and NUMS for its constituent, affiliated and administered colleges had a prior declared criteria of admission which the students in general were fully aware off. In view of the situation it was agreed that while in the current years admissions Aga Khan University and NUMS can be given permission to undertake their admissions under the declared criteria the admissions to remaining private colleges would be conducted centrally by the Commission.
(3) W	The mechanism for such merit based central admission must be ensured to be fully transparent and automated to remove the past experience of human tampering and disputes. The basic principal to remain that students should have the right to choose the college they wish to be admitted to based on where their merit places them. It was noted that in the past the upgradation system had created immense problem which was rooted in the fact that students were not at the outset allowed to make their own decision rather they were placed as per earlier preferences in different colleges with an assumed ranking of colleges created based on applicants merits. To ensure this does not happen the students must be given a clear choice at the time of issuance of merit lists to make their choice of free will as to which college they want to attend and once made such choice must be final to open the door for other students waiting to be offered admissions.
	It was clarified that no college is ranked currently by PMC or otherwise hence transfer of admissions cannot be claimed by a student after accepting admission to one college on the basis of these assumed rankings.
