#### **NOTIFICATION**

## HEC Scholarship Program - Balochistan & FATA Students

The Higher Education Commission Scholarship Program for Balochistan and FATA Students consists of 265 selected by HEC for placement in public colleges across Pakistan. The Pakistan Medical Commission reiterates its no objection to the Scholarship Program being conducted by the HEC and the selected students being admitted to public colleges.

Pakistan Medical Commission has at the request of the Government of Punjab, Government of Khyber Pakhtunkhwa, Balochistan and Azad Jammu & Kashmir enhanced the previous allocated strength of public colleges by 586 additional seats in public colleges in Punjab, KP, Balochistan and AJ&K to accommodate the HEC Scholarship Program and any other additional past quotas as represented by the relevant provincial governments.

For the placement of the students under the HEC Scholarship Program the following shall be applicable;

- 1. Students selected for the Program must have qualified their MDCAT examination (60% minimum marks) and obtained a minimum of 65% in their Higher Secondary examination. The admitting public university and HEC shall ensure the mandatory criteria is met.
- 2. HEC shall directly approach each Provincial Government for allocation of requisite seats for the Scholarship Program in public colleges administered by the Provincial Government.
- 3. The Provincial Government pursuant to powers vesting under Section 18 of the PMC Act, 2020 independently determine and allocate the necessary seats to HEC for the Scholarship Program in public colleges administered by them. Priority shall be granted to the Scholarship Program on the enhanced seats.
- 4. No student under the Scholarship Program shall be admitted over and above the allocated strength of each Public College as already notified by the PMC.
- 5. After the students on the Scholarship Program have been admitted, each Public University shall notify to the PMC of the names of the students and in which college they have been admitted by 21<sup>st</sup> March, 2021 to enable PMC to register the students for future licensing.
