Subject: - Irregularities during the Process of Conducting Interviews for Admission in Medical College

We have received the following complaints;

- i. A student named Areeba Sajid D/o Sajid Akhter CNIC No. 32102-7522502-2 and MDCAT Roll No. 2202396 with MDCAT score of 146 who scored 837/1100 in FSc. She was having an aggregate score of 59.33 out of 80 and his name was in additional merit list. Presently she is at merit standing 1 after the interview conducted by Sir Syed College of Medical Sciences for Girls, Karachi.
- ii. Another student named Aroosha Naveed D/o Naveed Aslam CNIC No. 38201-0738129-8 and MDCAT Roll No. 6306826 with MDCAT score of 172 who scored 958/1100 in FSc. She was having an aggregate score of 69.127 out of 80 and merit standing of 277 in PMC merit list sent to Sir Syed College of Medical Sciences for Girls, Karachi. Presently she is at merit standing 3 after the interview conducted by Sir Syed College of Medical Sciences for Girls, Karachi.
- iii. Another student named Hajra Rafiq D/o Muhammad Rafiq CNIC No. 36602-2633706-4 and MDCAT Roll No. 1500447 with MDCAT score of 170 who scored 959/1100 in FSc. She was having an aggregate score of 68.655 out of 80 and merit standing of 329 in PMC merit list sent to Sir Syed College of Medical Sciences for Girls, Karachi. Presently she is at merit standing 4 after the interview conducted by Sir Syed College of Medical Sciences for Girls, Karachi.
- iv. Another student named Nimra Khalid D/o Khalid Mehmood CNIC No. 34201-8155069-6 and MDCAT Roll No. 2700944 with MDCAT score of 161 who scored 949/1100 in FSc. She was having an aggregate score of 66.132 out of 80 and merit standing of 650 in PMC merit list sent to Sir Syed College of Medical Sciences for Girls, Karachi. Presently she is at merit standing 5 after the interview conducted by Sir Syed College of Medical Sciences for Girls, Karachi.

The following irregularities in the process of conducting interviews have been observed;

- a) Refusing to schedule interviews for students placed on the merit lists which would represent a misuse of the 20% marks allocated for interviews to colleges;
- b) Not providing a transparent interview mechanism and informing students of the marks obtained in the interviews;
- c) Confirming admission to students prior to having completed interviews of all candidates who have approached the college for seeking an interview and, subsequently admission.

The irregularities during the process of interview and selection of candidates may be explained within 03 days to the Commission and if an admission has been granted by violating PMC admission policy the same may be recalled with information and confirmation to the Commission on an urgent basis.
