2. Interested Suppliers/Service providers who fulfill eligibility criteria may submit their application for Pre-Qualification (**separately for each category**) on or before **28<sup>th</sup> April, 2022** at **1100 hours** along with requisite documents/information as mentioned below:-

- I. Registration with Income and Sales Tax.
- II. Complete profile including details of authorization as retailer/whole seller/authorized dealer/authorized re-seller etc. as well as information of business location, telephone numbers etc.
- III. Overall experience of at least (3) three years' in the relevant field (documentary evidence should be provided),
- IV. Bank Statement for last Six months, and
- V. Affidavit on judicial paper of Rs. 100/- that Supplier/Service provider is not blacklisted by any public sector organization.
