Provision of Information for Conduct of Inquiry and Conduct of Supplementary Examinations of Affiliated Colleges of Isra University, Hyderabad.

As per the decision of the Council, in the interest of the students and to safeguard their rights pertaining to colleges affiliated with the Pakistan Medical Commission, an investigation has been directed to be carried out into the affairs of the colleges affiliated with Isra University Hyderabad pursuant to reports received including public comments by the Vice Chancellor regarding disputes and management and control of the affiliated colleges.

A visit by the Member Examinations PMC appointed by the Council to conduct the inquiry has already been concluded of Al-Nafees Medical College, Islamabad. A visit to the other colleges shall be undertaken later this week. Pursuant to the visits and submission of fact finding report to the Council, the colleges and the university shall be called for an immediate hearing so as to ensure the inquiry is concluded by or before 15th March 2021.

For purposes of the completion of the inquiry and to comply with directions of the Council the following steps be taken and compliance confirmed on an immediate basis;

- In advance of the visits to Karachi and Hyderabad it is requested that complete
 details of results of each subject in all professional exams held in 2021 are forwarded
 to the undersigned recording roll number of students who passed and failed. The
 details by Al-Nafees Medical College have already been provided.
- 2. Any supplementary exams which may be scheduled by the University / colleges during March 2021 may be postponed immediately till after completion of the inquiry and further directions of the Council.
- 3. University shall provide details of management (dean/principal etc.) of each college recognized by them.
- 4. Each college shall provide details of management (dean/principal etc.) of the college as per their records.
- 5. The University and each college may provide by 6th March 2021 a written brief of facts / grievances / issues that they would like the Council to consider during the conduct of the inquiry.
